1.0 INTRODUCTION

One of the doctrines of the Budget's implementation framework towards ensuring fiscal discipline, budget integrity, value for money and service delivery is the monthly rendition of returns on Revenue and Expenditure by MDAs, followed by activities of the Budget Reconciliation Committee and the Budget Monitoring Committee. Consequently, the third quarter performance appraisal report provides an overview of the achievement of budget 2018 from January to December, 2018.

The objectives of the 2018 Budget are as follows:

- i. Completion of all critical on-going Capital Projects that are central to the six (6) Cardinal Programmes of the Government;
- ii. To improve on the level of Internally Generated Revenue and monitor same for the purpose of blocking all leakages of Government revenue;
- iii. A proper monitoring of income and expenditure of Government for transparency;
- iv. To curtail extra-budgetary spending;
- v. Improvement in the quality of Education;
- vi. To provide qualitative health services;
- vii. Sustenance of good governance through Budget discipline, probity and accountability in the utilization of Public Funds;
- viii. Improving on the socio-economic policy environment which is the bench mark of the Government Six (6) Cardinal Programmes;
- ix. To guarantee sustainable Agricultural Production with a view to ensuring food security, alleviating poverty, providing employment and to encourage Private Sector participation in Food Production; and;
- x. To Motivate the Public Service for effective and efficient service delivery.;

This report presents:

• An overall summary table of performance on Revenue and Expenditure.

- Review of 2016 2018 Q4 Budgets performance with explanatory notes
- The detailed report of returns from MDAs and Fiscal Coordinating Agencies.
- Conclusion and recommendations.

The process of compiling the Q4 Appraisal Report involved the following:

- (i) Collection of returns from MDAs through automation platform and the Fiscal Coordinating Agencies viz: Ministry of Finance and Economic Development, Ministry of Budget and Economic Planning, Office of the Accountant-General and the State Board of Internal Revenue.
- (ii) Collation of returns from MDAs and Fiscal Coordinating Agencies.
- (iii) The meeting of the Budget Reconciliation Committee held from Tuesday 15th Wednesday 16th January, 2019. The Committee members were

drawn from the Ministry of Finance and Economic Development, Ministry of Budget and Economic Planning, Office of the Accountant-General, Office of the Auditor-General and Board of Internal Revenue. The objective of the meeting was to reconcile and validate returns from MDAs and Fiscal Coordinating Agencies.

COMMENTS AND EXPLANATORY NOTES ON REVENUE PERFORMANCE

- FAAC: The Federal Allocation to the State recorded 104% (N38,019,908,660.69) level of performance as against the 82% recorded in 2017 and 77% recorded in 2016. This increase in performance in the FAAC statutory allocation could be attributed to the following reasons:
 - (i) Increase in the oil production level;
 - (ii) Increase in the Crude Oil price in the International Market;
- IGR (MDAs): IGR performance during the period under review was 82% as against 86% recorded in 2017 and 72% in 2016. The performance was due to the effectiveness of the e-payment platform and the strategies to block leakages.
- IGR (Tertiary Institutions): IGR performance for Tertiary Institutions in the period was 78% in the fourth quarter as against 136% recorded in 2017 and 99% recorded in 2016.
- VAT: VAT recorded 93% level of performance as against 91% recorded in year 2017 and 95% in 2016 respectively.
- **IDA:** The sum of **N2,989,194,048.00** representing **82%** realized during the period under review as against **77%** recorded in 2017 and nothing in 2016.
- Draw-Down: External (Grants/Loans): The sum of 10,422,519,415.10 representing 110% of Draw-Down was realized in the Fourth Quarter of 2018 as against 27% recorded in 2017 and 13% recorded in 2016.
- SDGs Conditional Grant Schemes: The sum of N1,200,000,000.00 was expected to be realized during the period under review. As at 31st December, 2018 nothing was realized from this Head.
- Loan Internal/Bond: The sum of N2,000,000,000.00 was expected to be generated from Internal Loans/Bond in the fourth quarter of the budgetary year, out of which no amount was realized from bond during the period under review.

- Grants from Federal Govt. (Reimbursement on Dualisation of State Road): The sum of N1,283,694,816.87 was expected to realized during the period under review, but nothing was realized from the Federal Government. This zero level of performance indicates the need for follow up action and concerted effort by the State Ministry of Works and Transportation for prompt reimbursement.
- **Ecological Fund**: The prorated sum of **N2,000,000,000.00** was expected to be generated from Ecological Fund in the fourth quarter of the budgetary year, out of which no amount was realized during the period under review.
- Excess Crude Oil Proceeds + Budget Differential: The sum of N2,000,000,000.00 was expected to be realized during the period under review. As at 31st December, 2018 the sum of N245,515,444.86 was realized representing 12% during the period under review as against 87% recorded in 2017 and 0% in 2016.
- Sundry Income: (FAAC Augmentation, Refund from NNPC & Proceeds from Sales of Fertilizer): The sum of N10,983,123,267.02 was expected from this Head as at the end of fourth quarter. As at 31st December, 2018 nothing was realized from this Head.
- Others: Sundry Income: The sum of N1,000,000,000,000 was expected from this Head as at end of the fourth quarter. The sum of N1,429,387,377.30 was realized during the period under review representing 143% performance as against 10% in 2017 and nothing was realized in 2016.
- Paris Club (Refund from Differential): The sum of N7,000,000,000.00 was projected for the year. As at 31st December, 2018 the sum of N3,934,272,411.44 representing 56% was realized from this source as against 136% recorded in 2017 and nothing was realized in 2016.
- Others (Transfer from Prior Fiscal Year): The sum of N7,000,000,000.00 was transferred to the current fiscal year and the total amount was expended on Capital Projects.

3.4 COMMENTS AND EXPLANATORY NOTES ON RECURRENT EXPENDITURE PERFORMANCE

- **Personnel Cost:** The level of Personnel Cost performance was **81%** in the fourth quarter as against **106%** in 2017 and **178%** in 2016.
- Other Charges: The Other Charges performance was 73% in the fourth quarter as against 65% recorded in 2017 and 86% in 2016.
- Recurrent Grants to Parastatals and Tertiary Institutions: 83% was recorded in the fourth quarter as against 79% recorded in 2017 and 35% in 2016 respectively.
- Transfer to Other Funds: 79% was recorded in the fourth quarter as against 67% in the 2017 and 80% in 2016 respectively.
- Consolidated Revenue Fund Charges: 88% was recorded in the fourth quarter of 2018 as against 83% recorded in 2017 and 96% in 2016 respectively.

6.0 CONCLUSION AND RECOMMENDATIONS

The Fourth Quarter Appraisal of 2018 Budget was carried out with a view to determining the actual level of performances of returns on Revenues and Expenditures by MDAs in the State in the period under consideration. The overall performance level of the Revenue estimate was 78% as against 74% recorded in 2017. It should be noted that 78% was recorded in the Internally Generated Revenue of Tertiary Institutions while the performance of Ministries, Departments and Agencies (MDAs) was 82% in the fourth quarter of 2018. However, the performance can be improved upon through further concentration of the Internal Revenue Service on the informal sector of the State in the next fiscal year.

The Budget appraisal also indicated that the performance level of recurrent expenditure is more than the capital expenditure by ratio **82:33** as against ratio **88:42** in the 2017. It is expected that concerted efforts would be made to improve on the implementation of Capital projects in the next fiscal year.

It is hoped that the experience acquired in appraising the Budget would be brought to use for better implementation in the next fiscal year.
