1.0 INTRODUCTION

Ekiti State is eligible to receive performance based grant financing from the Federal Government subject to performance against predefined criteria in the World Bank Assisted States Fiscal Transparency, Accountability and Sustainability Program to provide fiscal relief to States in response to COVID-19 The monthly Budget Execution Report of the Government of Ekiti State for the months of August and September, 2020 as set out in Annexure I & II have been audited under my direction in accordance with section 125 (2) of the Constitution of the Federal Republic of Nigeria, 1999 (as amended) and section 26 (2) of Ekiti-State Audit Law (No 11) of 2014.

2.0. BUDGETED AND ACTUAL COVID-19 REVENUE

The sum of Eight Hundred Million Naira (N800,000,000.00) only was projected as COVID-19 proceed in the State's COVID-19 Responsive 2020 Revised Budget.

In the period under review, which was the 3rd Quarter of the current year the actual COVID-19 revenue received was N1,030,536,000.00. The sums of N30,500,000.00 and N1,000,036,000.00 were received in the months of August and September respectively.

The amount received in August was transferred from the State account (UBA Capital Account) to COVID-19 dedicated account at UBA.

Included in the amount received in September was the sum of N1,000,000,000.00 released to the State Government by the Federal Government for COVID-19 response and recovery program.

However, the actual year to date (March – September) COVID-19 revenue received was N1,734,077,864.01. The detail is as follows:

3.0. BUDGETED AND ACTUAL COVID-19 RESPONSE AND RECOVERY EXPENDITURE.

The total amount allocated for COVID-19 response and recovery expenditures in the 2020 Revised Budget was Twenty-Three Billion, Seven Hundred and Sixty-Six Million, Four Hundred and Fourteen Thousand, Eight Hundred and Fifty-Two Naira and Twenty-Two kobo (N23,766,414,852.22) only. The amount allocated for COVID-19 expenses was 26.08% of the Total Budgeted Expenditure of N91,128,996,482.01 in the COVID-19 Responsive 2020 Revised Budget.

The actual COVID-19 response and recovery expenditure for the period under review was N2,092,103,703.91 (N1,215,976,461.16 for August, 2020 and N876,127,242.75 for September, 2020) and the year to date (March - September) actual expenditure was N11,120,192,524.20 translating to 47% budget performance as at 30th September, 2020.
