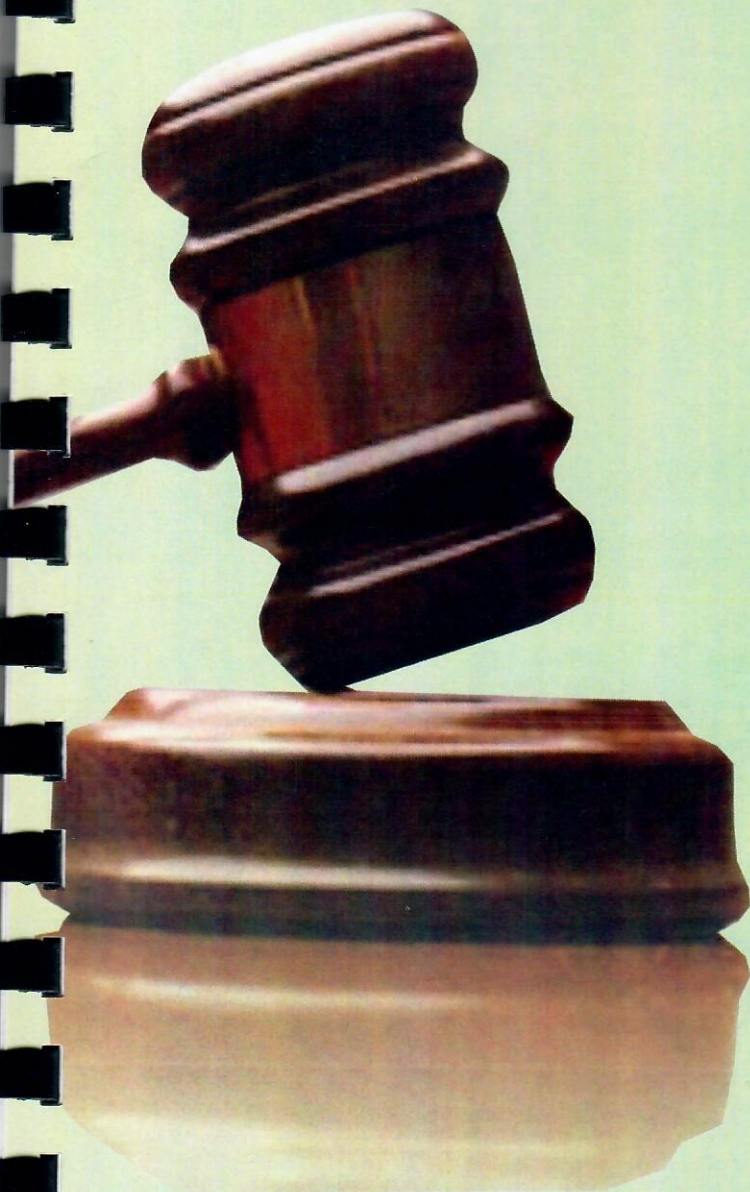

ENACTED BY THE HOUSE OF ASSEMBLY OF EKITI STATE AS FOLLOWS:

Amendment of Ekiti State Joint Local Government Account and Allocation Of Revenue Law, Cap S8, Laws of Ekiti State, 2012. **1.**

1. The provisions of the Ekiti State Joint Local Government Account and Allocation of Revenue Law, Cap. S8, Laws of Ekiti State, 2012 (in this Law referred to as “the Principal Law”) is hereby amended as set out in this Law

Annual audited Account.


*Amendment of

2. Section 6 (1) of the Principal Law is hereby amended by substituting subsection (1) of Section 6 with a new subsection (1) to now read as follows:
- Section 6 (1): *The JAAC account shall be audited annually by the Auditor-General for Local Governments.***


Citation.


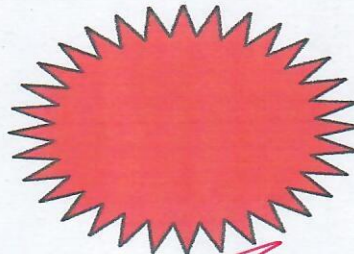
