




1.6.3 FUNCTIONS/POWERS OF THE COMMISSION

- 1.6.3.1 The Ekiti State Civil Service Commission is a creation of the 1999 Constitution of the Federal Republic of Nigeria as contained in Section 197 part II, Third Schedule as amended. The Civil Service Commission is responsible for the appointment, promotion and discipline of all Civil Servants in the State. However, the Commission has delegated its power in respect of appointment, promotion and discipline of all Officers on Grade Level 06 and below to Heads of Ministries, Departments and Agencies (MDAs) for smooth and speedy operation.
- 1.6.3.2 The Commission was involved in the following activities in the period under review:-
 - Appointment (including Contract and Temporary Appointments) into post on salary Grade Level 07-17;
 - ii. Promotion/Advancement of officers to posts on Grade Levels 07-17;
 - iii. Attending meetings of Staff Management Committees in Ministries, Departments and Agencies (MDAs);
 - iv. Monitoring the activities of Ministries, Departments and Agencies over appointments, promotions and discipline of officers below Grade Level 07 in order to ensure that the appropriate Rules, Regulations and Guidelines are strictly and uniformly applied and adhered to;
 - Serving as an Appellate Body for all petitions emanating from Ministries/Extra Ministerial Departments in respect of promotion, staff welfare, discipline matters etc;
 - vi. Ensuring full compliance with Federal Character Commission principles of


- equitable representation of all Local Governments of the State in all appointments made by the Commission, Ministries and Extra-Ministerial Departments of the State.
- vii. Exercising disciplinary measures on erring officers in the Civil Service.
- viii. Processing retirement/withdrawal of service and resignation of appointment of officers;
- ix. Processing of applications for Lateral, Inter-State, Inter-cadre transfers of services and Secondment of officers;
- x. Confirmation of appointments of officers on grade level 07 and above:
- xi. Laying down guidelines from time to time to regulate the effective and uniform implementation of the Civil Service Rules and Regulations in all Ministries, Departments and Agencies.

- (v) Processing of Conversion, Advancement and Absorption of Officers on Grade Level 07 and above in the State Civil Service;
- (vi) Processing requests for Merging of Service and Contract Appointments into the State Civil Service;
- (vii) Sales of application forms for appointment into the State Civil Service;
- (viii) Confirmation of appointment;
- (ix) Ensuring full compliance with Federal Character Commission principles
- (x) Gazeting appointments;
- (xi) Processing and conduct of ASCON Public Service Examination and preparing ground for the conduct of the subsequent Extended and Commissioners interviews;
- (xii) Processing of integration into the Civil Service.
