In pursuant EKITI STATE BOARD OF INTERNAL REVENUE (FIRST AMENDMENT) LAW, 2020 - <u>https://ekitistate.gov.ng/wp-content/uploads/2020/irsLaw2020.pdf</u>, and Ekiti State Fire Service Law, 2023 all business owners in Ekiti State are required to obtain Fire Safety Certificate for their business premises by following the underlisted process:
