CONCLUSION I

5.1.5 Since the Memorandum on State Action on Business Enabling Reforms (SABER) was desirable, Council:

- i. noted the extension of the SABER programme till year 2026;
- ii. noted the readiness of Ekiti State to continue its participation in the World Bank State Action on Business Enabling Reforms (SABER) programme;
- iii. noted the improved ranking of Ekiti State from 18th to 10th position in the Sub-national Ease of Doing Business Report 2025 by the Presidential Enabling Business Council (PEBEC) Secretariat;
- iv. noted that the Year 2026 Ekiti BERAP document had been reviewed and cleared by the PEBEC Secretariat;
- v. noted that the Year 2026 Ekiti BERAP document was prepared with Power Point as against the previous Excel format to enhance ease of reading and understanding by the public;

- vi. noted that the picture of Ekiti EoDB Steering Committee Chairman was attached with his signature appended on the Year 2026 Ekiti BERAP document;
- vii. noted that the organized private sector had unanimously agreed that the Year 2026 Ekiti BERAP document be presented to the State Executive Council for approval;
- viii. noted that the online publication of year 2026 Ekiti BERAP was one of the eligibility criteria for interested States to continue their participation in the SABER Programme for year 2026;
- ix. noted that the deadline for publication of the Year 2026 Ekiti BERAP document was 31st of December 2025;
- x. noted that the Year 2026 Ekiti BERAP document had to be presented to the State EXCO prior to its online publication;
- xi. noted that His Excellency, the Governor had approved the presentation of the Year 2026 Ekiti BERAP document for State EXCO's ratification and subsequent approval; and
