### **REGULATORY PROCESS FOR OBTAINING ENVIRONMENTAL AND SOCIAL IMPACT ASSESSMENT REPORT APPROVAL IN EKITI STATE**

Ekiti State Environmental Protection and Watershed Management Agency Law of 2024 which was enacted in tandem with the Environmental Impact Assessment Act CAP E12 LFN 2004 and Ekiti State Revenue Administration Law, 2025 [https://ekitistate.gov.ng/wp-content/uploads/saber/New/Revenue\\_Administration\\_Bill\\_2025.pdf](https://ekitistate.gov.ng/wp-content/uploads/saber/New/Revenue_Administration_Bill_2025.pdf) stipulated that Environmental Impact Assessment should be performed before siting of any business buildings and other land uses in Ekiti State. The businesses are required to pay fees for the issuance of Environmental Impact Assessment approval through the following regulatory process:
